Dear Member:

On behalf of your Board of Directors of Signature Federal Credit Union, I am pleased to invite you to attend the 54th Annual Meeting of Signature Federal Credit Union, which will be held on Wednesday, August 13, 2025, in Dallas, TX at the UPMA National Convention.

The members listed on the reverse side, with brief biographical data, have been nominated by the Nominating Committee as candidates for three (3) positions on the Board of Directors and one (1) position on the Credit Committee. All candidates have indicated their willingness to serve in the office, if elected.

Additional nominations may be made by petition. Each petition must be signed by one percent of the members. The total membership of Signature Federal Credit Union on December 31, 2024, was 27,077, requiring a minimum of 271 signatures on a petition to nominate additional candidates. Signatures will be checked against membership lists, and petitions with insufficient valid signatures will not be eligible to make a nomination. The election will not be conducted by ballot when there is only one nominee for each position to be filled. Each nominee by petition shall submit a statement of qualifications and biographical data with the petition, accompanied by a signed certificate from the nominee stating that they are agreeable to nomination and will serve if elected to office.

The closing date for receiving nominations by petition is June 19, 2025, at our office in Alexandria, Virginia where they will be received by the Secretary of the Board of Directors. Nominations shall not be made from the floor unless sufficient nominations have not been made by the Nominating Committee or by petition to provide for one nominee for each position to be filled, or circumstances prevent the candidacy of the one nominee for a position to be filled. Only those positions without a nominee shall be subject to nominations from the floor. If sufficient nominations have been made by the Nominating Committee or by petition to provide more than one nominee for any position to be filled, the Secretary of Signature Federal Credit Union shall, at least 30 days prior to the Annual Meeting, cause ballots to be sent to all members eligible to vote.

Each voting member shall receive:

- (1) One paper ballot, clearly identified as such, on which the names of the candidates shall be printed in order as determined by the draw of lots. Brief biographical sketches will accompany the ballot. NO SEPARATE ID FORM IS REQUIRED. A UNIQUE BAR CODE IS INCLUDED ON YOUR BALLOT SO THAT YOUR IDENTITY IS VALIDATED. A THIRD PARTY ADMINISTERS THE ELECTION, ENSURING THE SECRECY OF YOUR BALLOT.
- (2) Or members who have previously opted to vote electronically will not receive a paper ballot; they will receive an email with election code and voting PIN.

It shall be the duty of the Tellers of Election to verify the name of the voter and their credit union member number as appearing within the unique bar code. Ballots will be held, pending the count of the vote. In the event of a challenged vote count, ballots will be re-counted and verified by the Tellers of Election.

IMPORTANT NOTICE: THE VOTING PROCEDURE MUST BE FOLLOWED. EXCEPTIONS TO THESE INSTRUCTIONS WILL CAUSE THE BALLOT TO BE DISQUALIFIED.
