- Your organization will receive 5% of the revenue (interest) generated off your members' affinity card usage (paid quarterly).

As members of the Credit Union, your association employees can take advantage of this non-variable, low rate Visa Platinum credit card with no annual fees, no minimum finance charges, no balance transfer fees, and free cash advances that carry the same rate as purchases.
